Sealed bids will be received at the City Hall Council Chambers, Second Floor, 260 High Street, Perth Amboy, NJ on **December 20th, 2018 at 10:00 a.m.** for the following:

Refurbish Transfer Station Equipment

In compliance with the Proposal Form and Specifications and Instructions to Bidders, on file in the Office of the Purchasing Agent, 260 High Street, Perth Amboy, NJ

Bid Proposal Packages (Proposal Form and Specifications and Instructions to Bidders) will be available to bidders in the Office of the Purchasing Agent, 260 High Street, Perth Amboy, New Jersey **on or after December 11th, 2018**. **A pre bid meeting will take place at the Transfer Station – 599 Fayette Street at 10:00am on December 13th, 2018**

Sealed bids will be received when called for by the **Purchasing Agent** or his designee at the time and place set forth above in this Notice. Said Bids can be mailed or hand delivered to the Purchasing Agent, City Hall, 260 High Street, Perth Amboy, NJ prior to the date and time stated. **THE CITY IS NOT RESPONSIBLE FOR LATE DELIVERY BY ANY COURIER OR THE POSTAL SERVICE.**

Bidders are required to comply with:

- (1) Each bid shall be accompanied by a certified check, cashier check or bid bond payable to the City Treasurer of the City of Perth Amboy, as a guarantee that if contract is awarded to him he will enter into a contract therefore. The amount so deposited shall be ten percent (10%) of the bid, but in no case in excess of \$20,000.00. N.J.S.A 40A11-14 provides that the Governing body of any municipality may provide the form and manner of approval of all guarantee, indemnity, fidelity or other bonds required.
- (2) Affirmative Action Regulations requirement of N.J.S.A.10:5-31 et seq. and N.J.A.C.17:27;
- (3) P.L.2004, c.57 which amends and supplements the business registration provision of N.J.S.A.52:32-44

Each bidder must strictly comply with all requirements for a regular bid as directed or required by the specifications and the Statutes in such case made and provided.

The Purchasing Agent reserves the right to reject all bids if deemed in the best interest of the City of Perth Amboy to do so and his actions are subject to the approval of the Mayor and Council of the City of Perth Amboy. **Notice is hereby given to all bidders that if their bids are informal, defective, or irregular, the same will be rejected.**
