



POWERFUL BUSINESS INCENTIVES

- Business in Perth Amboy's UEZ receive powerful benefits that include:
- **3 1/2 % Sales Tax** — Businesses can cut in half the NJ State Sales tax of 7%. This means that your customers pay only 3 1/2%! Merchants help their community because the 3 1/2% sales tax stays in Perth Amboy to fund other programs for businesses.
- **Employee Tax Credits** — Hire new employees and your company may receive a direct tax credit of \$500 or up to \$1,500.
- **Sales and Use Tax Exemption**— Business owners pay no sales tax on most purchases related to running their business. Whether you buy office equipment or supplies, furniture, fixtures, construction materials or make repairs you pay NO taxes.
- **Unemployment Insurance Rebates**— Receive up to 50% reduction on your unemployment insurance bill for the first four years.
